Electricity (limited): additional \$5.00 – each booth is limited to one extension cord

to be plugged into the electrical box. A surge protector **must** be used between the extension cord and the appliance. **NO ELECTRIC HEATERS ARE ALLOWED!**

Payment after February 15, 2012 must be by Money Order or Cash.

Set-up Time

Vendors may begin set-up on Friday from 3:00 - 6:00 p.m. or Saturday at 6:30 a.m. Entrance to the Market is from the Nederland Ave. end of 17th Street. Vehicles and trailer must be in place no later than 8:00 a.m. No driving is allowed in the C & C Market after 8:00 a.m. on Saturday and 11:00 a.m. on Sunday. If there is room, vehicles may be left in your space. Absolutely no stakes or permanent marking may be used on the concrete or asphalt surfaces. No one is allowed to move into an unoccupied space without permission. Exhibitors must provide their own display equipment. Booths not occupied by 9:00 a.m. on Saturday will be considered forfeited and may be used at the discretion of the Board of Directors with no refund to original holder of the booth.

Show Hours: Saturday, 9:00 a.m. - 6:00 p.m.

Sunday, Noon - 5:00 p.m.

No Vehicle Traffic will be allowed in show area prior to closing. In an effort to help during heavy traffic on Sunday evening, please have your display, including canopy, completely dismantled before you bring in your vehicle. You will be directed by Festival volunteers & Police Officers on procedure for exiting the area.

Selling Policy:

1. No selling of tobacco, firearms, knives, exploding toys, hair paint, can string, laser pointers, paint toys, fake/look a-like cigarettes, beepers, fire crackers, or commercially produced can goods.
2. No selling outside of your rented area. This includes standing in front of the designated area.
3. All vendors are **required** to have products available for purchase and their primary purpose is the selling of the product. Anyone distributing informational pamphlets or promotional material must submit a sample with their application.
4. Taking of opinion polls or surveys will not be allowed.
5. Vendors may **not** sublease their booth without permission from the NHF Executive Board. Your booth will be forfeited for violation of the policy.

Vehicle Policy:

1. Vehicles parked in spaces must remain there until the show closes each day. Your vehicle must be parked in your space or outside of the barricades on 17th Street or your vehicle will be towed at your expense. Parking is available behind the school across from the market.
2. When leaving at the end of the day, check with NHF Volunteers & Nederland Police Officers for directions.
3. If an emergency arises, contact the C & C Market Chairman in booth space 14 for an escort off the premises.

Clean-up: Vendor's area must be cleaned before they will be allowed to leave. Contact booth 14 for large trash removal.
