

**2027 NEDERLAND HERITAGE FESTIVAL
CORN HOLE TOURNAMENT RULES**

Date: Saturday, March 13th

Fee: \$10.00 per player (\$20.00 Team) NO CHECKS ACCEPTED!
Prizes: 1st Place - \$200.00 & T-shirt
2nd Place - T-shirt

1. Teams compete in a single head-to-head, and the loser of each match is eliminated until a champion emerges.
2. Corn Hole Boards are placed 27 feet apart. Players stand on either side of their respective board and must throw from behind the front edge of their own board. Players take turns throwing bags at the opposite board. Each player throws 4 bags per round.
3. Teams consist of 2 players who stand on opposite boards and stay in their designated lane while throwing their 4 bags.
4. The teams will be arranged by randomly drawing of team names.
5. There will be a coin toss to determine which team throws first, the winner gets the choice if they or their opponent throws first.
6. A bag in a hole scores 3 points. A bag on the board scores 1 point. No points are awarded for bags that touch the ground before landing on the board. Only one team can score in each round. If Team A scores 6 points and Team B scores 4 points in the same round, Team A gets 2 points ($6-4=2$)
7. The game continues until a team reaches 21 points at the end of a round.
8. The Nederland Heritage Festival reserves the right to refuse any team or require any team to leave.
9. Bags will be provided. Can throw ACL permitted bags only!
